**RECOMMENDATION:**

I move that Council adopt an ordinance for Option A or Option B to amend Chapter 18, Section 123, Designated prohibited parking areas, and Chapter 18, Section 148, Prohibited areas for parking-at all times. In reference to Option A; no parking on Water Street (north side) from Market Street, eighty-five (85) feet to the east, or Option B; no parking on Water Street (north side) from Market Street to 156 Water Street.

**BACKGROUND AND FINDINGS:**

This request is to prohibit parking on the north side of Water Street (option A) from Market Street, eighty-five (85) feet to the east, or (option B) from Market Street to 156 Water Street. Option A will eliminate 3 parking spaces and improve line of sight for vehicles turning out from Market Street. Option B will eliminate 9 parking spots and allow for clear paths of travel in both directions.
